Mayor Levine opened the Public Hearing on Proposed Local Laws No. 1-2010 at 7:12 p.m.

PROPOSED LOCAL LAW NO. 1 OF 2010 AMENDING CHAPTER 121 OF THE CODE OF THE

VILLAGE OF OLD FIELD AS IT RELATES TO FEES AND DEPOSITS REQUIRED FOR APPLICATIONS TO THE BOARD OF APPEALS AND APPLICATIONS FOR SITE PLAN REVIEW

Section 2. Amendments.

Article IX, Chapter 121 of the Code of the Village of Old Field shall be amended to read as follows:

Sec. 121-47. Meetings and procedures.

* * *

- L. Fees and deposits.
 - (1) The schedule of required fees and deposits is as follows:

Item	Amount
Filing fee	\$500
Hearing deposit	\$2,000

* * *

(3) The Village may charge applicants all costs for engineering, legal, accounting, environmental and other professional services and such other expenses reasonably incurred by the village in connection with an application to the Board of Zoning Appeals. The applicant's hearing deposit shall be charged for theses expenses. Additional expenses that exceed the deposit shall be paid by the applicant within 30 days of notification. Failure to reimburse the village for expenses as required may at the Board of Zoning Appeal's discretion, result in suspension of the applicant's matter pending before the Board. No building permit, demolition permit or certificate of occupancy shall be issued until all required fees and deposits have been paid in full.

B. Site review expenses.

* * *

(1) Each applicant shall be liable for and shall pay the actual and necessary charges which have been incurred by the village in connection with the review of

the application, including engineering and inspection, consultant, stenographic minutes, recording fees, and legal fees. Reimbursable engineering fees shall include, where applicable, the Village's cost to review stormwater pollution prevention plans (SWPPP's) and inspect stormwater management practices to ensure that they comply with Chapter 94, the Village's stormwater management and erosion and sediment control law.

(2) Expenses incurred pursuant to this Subsection B shall be deducted from the deposit as incurred. If actual expenses exceed the deposit, the applicant is responsible for payment. To the extent that expenses exceed the deposit on hand, the applicant shall pay the balance due and make an additional deposit as deemed necessary by the SPR Board before the review continues to the next stage of review. No decision will be rendered until all outstanding payments of expenses are received by the Village. After filing of the final decision, all unexpended funds of the deposit shall be refunded.

Section 2. Severability.

If any clause, sentence, paragraph, section, or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part hereof directly involved in the controversy in which judgment should have been rendered.

Section 3. Effective date.

This local law shall take effect immediately upon filing with the New York Secretary of State.

The Mayor closed the Public Hearing on Proposed Local Law No. 1-2010 and opened the regular Board of Trustees meeting at 7:12 p.m.

The proposed action is an Unlisted Action pursuant to SEQRA. Accordingly, a motion was made by Trustee Gulbransen and seconded by Mayor Levine to adopt a Negative Declaration pursuant to SEQRA, determining that Local Law No.1-2010 will not have a significant adverse effect on the environment and neither a draft environmental impact statement nor a final environmental impact statement will be prepared. The motion was unanimously approved 5-0 with Trustees Gulbransen, Owen, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

Thereafter, upon a motion made by of Trustee Rosenberg and seconded by Trustee Owen, Proposed Local Law No. 1-2010 was unanimously approved 5-0 with Trustees

The motion was approved 4-1 with Trustees Owen, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion. Trustee Gulbransen voted against the motion.

TREASURER'S REPORT

A motion was made by Trustee Gulbransen and seconded by Mayor Levine to approve the Treasurer's Report and payment of warrants for February 2010. The motion was approved 5-0 with Trustees Gulbransen, Owen, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.
