Mayor Levine called the meeting to order at 7:05 p.m.

ELECTION RESULTS AND SWEARING-IN CEREMONY

Mayor Levine announced that the following individuals had been re-elected in the March 16, 2010 election:

Trustee Rosenberg recited the oath of office in a swearing in ceremony for Mayor Levine.

Mayor Levine then recited the oath of office in a swearing-in ceremony for Trustees Gulbransen and Rosenberg and Justice LaVita.

NEW BUSINESS

WIND TURBINE GENERATORS

Five members of the Windmill Committee, established to study the impact of residential wind turbines, offered the following diverse and contrary opinions:

- The impact on neighbors and community outweighed the benefit that might be created with wind turbines. Solar initiatives could be employed for better outcomes. Cutting edge technologies now in developmental stages should be available in the next 12-18 months. (Hard copy findings were presented to the Board.)
- The Village should take a pro-active role in the use of alternative energy sources to offset the impact of high energy homes.
- Statistics indicate wind turbines as inefficient on a small home scale.
- Both the noise and aesthetic impact of a 30' tall wind turbine system are minimal. Wind turbines should be approved with reasonable restrictions. (Hard copy findings were presented to the Board.)
- Residential wind turbines should be approved but only if strict restrictions are established for site views, setbacks and noise.

One of the more compelling arguments raised in the lengthy discussion that followed was that the same renewable energy could be purchased directly, without detrimental impact on Old Field neighbors, through green energy investment programs sponsored by LIPA and others. While no consensus was reached among the Committee or Board members, Mayor Levine noted that he would take guidance from the initiatives of other villages on Long Island.

MS4 GRANT OPPORTUNITY

Erin Brosnan of EEA, a local environmental consulting firm, was hired by the Board to investigate grant opportunities that would help finance strormwater runoff solutions for Old Field Road. After meeting with the DEC, Ms. Brosnan reported that a grant opportunity now exists with the Long Island Sound Futures Fund ("LISFF"). If successful, the first stage of the grant would fund the design of a stormwater improvement project. The second step would fund the installation. She suggested the Village move forward with this grant opportunity to design infiltration basins and bioswales in 4-5 locations along Old Field Road to slow, divert and reduce sediment flow before runoff reaches Conscience Bay.

After lengthy discussion, the Mayor asked Ms. Brosnan to review her findings and report back to the Board later in the week.

INTRODUCTION OF PROPOSED LOCAL LAW #2-2010
