PROPOSED LOCAL LAW NO. 3 OF 2010 AMENDING CHAPTER 121 OF THE CODE OF THE VILLAGE OF OLD FIELD AS IT RELATES TO WIND ENERGY CONVERSION SYSTEMS ("WECS") AND OTHER STRUCTURES IN THE VILLAGE OF OLD FIELD

PROPOSED LOCAL LAW NO. 4 OF 2010 AMENDING CHAPTER 121, ARTICLE X, OF THE CODE OF THE INCORPORATED VILLAGE OF OLD FIELD AS IT RELATES TO ENFORCEMENT OF UNLAWFUL ACTIONS

Public Hearing on Proposed Local Law 4-2010 was held on June 8, 2010. At that time the Board adopted a Negative Declaration pursuant to SEQRA, determining that Local Law No.3-2010 will not have a significant adverse effect on the environment, and agreed to proceed to vote at a later date pending the decision of the Suffolk County Planning Commission.

PUBLIC HEARING ON LOCAL LAW # 5 OF 2010

PROPOSED LOCAL LAW NO. 5 OF 2010 AMENDING CHAPTER 5 OF THE CODE OF THE VILLAGE OF OLD FIELD AS IT RELATES TO ANIMAL WASTE IN THE VILLAGE OF OLD FIELD

Be it hereby enacted by the Board of Trustees of the Incorporated Village of Old Field as follows:

Section 1. Legislative findings.

The Board of Trustees finds that the adoption of a law to control animal waste is necessary to supplement the Phase II stormwater regulations adopted by New York State Department of Environmental Conservation and to protect and safeguard the general health, safety, and welfare of the residents of the Village of Old Field.

Section 2. Amendments.

Section 5-3 of the Code of the Village of Old Field is hereby amended to read as follows:

- A. No person owning, possessing, harboring or having custody or control of any animal shall permit or allow such animal to disturb the comfort, peace or repose of a reasonable person of normal sensitivities in the vicinity by continued or frequent noise or odor.
- B. No person owning, possessing, harboring or having custody or control of any animal shall permit such animal to defecate on any public street, road, or highway, including the right-of-ways thereof, or other public place, or on any private street that produces stormwater runoff that drains into a municipal separate storm sewer system, unless such feces are immediately removed in a sanitary manner.
- C. No person owning, possessing, harboring or having custody or control of any animal shall permit such animal to defecate or urinate on private property without the consent of the owner or person in possession of such property. It shall be presumed that an animal defecating or urinating on private property does so without the consent of the owner or person in possession of such private property.

Section 3. Severability.

If any clause, sentence, paragraph, section, or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part hereof directly involved in the controversy in which judgment should have been rendered.

Section 4. Effective date.

This local law shall take effect immediately upon filing with the New York Secretary of State.

Upon motion made by Trustee Gulbransen and seconded by Mayor Levine, Mayor Levine closed the Public Hearing on Proposed Local Law No. 5-2010 and opened the regular Board of Trustees meeting at 7:19 p.m.
