Mayor Levine called the meeting to order at 7:07 p.m.

RESIGNATION OF VILLAGE TREASURER

The Mayor reported Anne Cadden has submitted her resignation as Treasurer, effective December 15, 2008. The Mayor and Members of the Board of Trustees expressed their deep appreciation for her valuable contributions to the Village. On motion made by Trustee Pius and seconded by Trustee Gulbransen, the following resolution was unanimously approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

RESOLVED, that the resignation of Anne Cadden as Village Treasurer of the Incorporated Village of Old Field be, and it hereby is, accepted effective December 15, 2008; and

FURTHER RESOLVED, that the Board of Trustees records its appreciation and gratitude to Anne Cadden for all of her hard work for the betterment of the Village of Old Field; and

FURTHER RESOLVED, that the above resolution be recorded in the official minutes of the Village in recognition and with thanks from the Village residents that she served so well.

PUBLIC HEARING

A Public Hearing was held on the application of Chardon, to amend (or obtain relief from) a Covenant and Restriction on property located at 126 Old Field Road. A transcript of the Public Hearing is available at Village Hall.

A motion was made by Trustee Pius and seconded by Trustee Rosenberg to continue the Public Hearing at the next regularly scheduled Board of Trustees meeting on January 13, 2009. The motion was approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

Mayor Levine called the Board of Trustees regular meeting to order at 7:41 p.m.

MINUTES

A motion was made by Trustee Pius and seconded by Trustee Rosenberg to approve the Minutes of the Board of Trustees meeting of November 11, 2008. The motion was approved 4-0-1 with Trustees Rosenberg, Pius and Shybunko and Mayor Levine voting in favor of the motion. Trustee Gulbransen abstained.

TREASURER'S REPORT

CORRESONDENCE

The Mayor reported that he had received a letter from Dr. Colin Clarke asking the Village to look into the feasibility of amending the Village Code to permit residents to install small wind systems on their property.

ENVIRONMENTAL REPORTS

A motion was made by Trustee Pius and seconded by Trustee Gulbransen to approve the Zoning Permit application of **Owen 164 Old Field Road**, to remove trees on the resident's property and on the Village right-of-way subject to the following conditions:

- 1. Removed trees must be replaced on a 1-1 ratio; and
- 2. Square footage of woody shrubs must remain the same; and
- 3. Plantings must stay 5' off Old Field Road; and
- 4. A visible buffer must be maintained for two-thirds of the frontage. One-third of the frontage may be cleared.

The motion was approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

A motion was made by Trustee Shybunko and seconded by Trustee Gulbransen to deny the Building Permit application of **Eielson, 69 West Meadow Road** for an:

83 sq. ft. first floor addition;

426 sq. ft. second floor addition; and

211 sq. ft. screed porch

on the basis that the building lot is under two acres. The motion was approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

A motion was made by Trustee Pius and seconded by Trustee Rosenberg to approve the Building Permit application of **Patel**, **166 Old Field Road** to install an in-ground pool. The motion was approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.

A motion was made by Trustee Pius and seconded by Trustee Gulbransen to approve the application for a Demolition Permit for **Terrapin Crossing**, to remove the current residence at **59 Crane Neck Road** subject to the following conditions:

- 1. the concrete foundation must be removed from the property in its entirety; and
- 2. the soil must be stabilized to protect it from erosion.

The motion was approved 5-0 with Trustees Gulbransen, Pius, Rosenberg and Shybunko and Mayor Levine voting in favor of the motion.
