Jeff Schnee went over the new 5G technology that will become available, and the 4G that is now in use. John Vonlintig suggested a Committee to study other alternatives than the Unipole, with Mark Eghrari volunteering as Chair. Oleg Gang and will also participate. They will report back to the Board with their findings.
