# A PROPOSED LOCAL LAW AMENDING CHAPTER 64 OF THE CODE OF THE VILLAGE OF OLD FIELD AS IT RELATES TO NOISE

BE IT HEREBY ENACTED, by the Board of Trustees of the Incorporated Village of Old Field, as follows:

# Section 1. Amendments.

Section 64-12 of the Code of the Village of Old Field is hereby amended to read as follows:

§ 64-12. Time restrictions.

<u>The following acts are prohibited</u> between the hours of 6:00 p.m. and 8:00 a.m. of the following morning, and at any time on Sunday and public holidays as defined in § 64-1, and at any time on Saturdays between Memorial Day and Labor Day each year, the following acts are not permitted:

- A. The construction, demolition, alteration or repair of any building or the operation of construction machinery. Nothing herein shall be construed to prohibit minor alteration to the interior of a building, which is entirely enclosed, or the use of small power tools and machinery for the maintenance of a person's property.
- B. The use or operation of any landscaping equipment by a commercial landscaper.
- C. The use or operation of any recreational vehicle on private or public property.
- D. The use of explosives, firearms or similar devices, except as otherwise permitted by law.

#### Section 2. Severability.

If any clause, sentence, paragraph, section, or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part hereof declared by said court to be invalid.

#### Section 3. Effective Date.

This local law shall take effect immediately upon filing with the Office of the New York Secretary of State.

Trustee Shybunko-Fire, Special Projects: Elite Towers has not heard from the Cell Tower Committee. The Mayor has requested they attend the next meeting to report on their findings. Anthony Guardino discussed the US Coast Guard need for an approval for a cell tower located at the Lighthouse, will reach out to them again.

Trustee Owen-Parks, Building, Street Trees

Trustee Bruce Feller-Environmental Council

Thomas Pirro-Street & Road Repairs: The estimate for sealing the road cracks has been received, waiting for the estimate for re-striping the roads.

### **Additional Public Comments**

Pam Dellapietra, 23 Wheeler Road, discussed the flooding conditions on her property at 120 Old Field Road. She feels the water run off causing the pond on her property to overflow comes from Old Field Road. Mayor Levine said he had videotaped the roads during a heavy rain storm, and that run off from Old Field Road is not the problem, but a lack of drainage on the property. Trustee Owen said the property is in a kettle hole, the water levels are high. The Mayor will have the Village Engineer meet with Ms. Dellapietra's engineer to review the issues.

Don Pius discussed the new proposed LL 2019-02, verifying no commercial equipment to be used on Saturdays between Memorial Day and Labor Day, questioned recreational vehicle use. The Board discussed eliminating

golf carts as a recreational vehicle. Trustee Owen suggested also eliminating "routine landscaping maintenance" from prohibited work. The Board discussed eliminating any work that requires a permit.

Ted Rosenberg discussed the lot coverage allowance calculation for the Zeniou project, and other ongoing issues regarding the tree removals. The Board will have the lot allowance calculation reviewed by an engineer.
