Building

• On a motion by Trustee Pirro, seconded by Trustee Owen, the Board approved Blaney, Keith & Erin, 20 Crane Neck Road, permit #2020-0043, for the renovation of the roof, front and rear porches, beams, walls, ceilings, windows, add one bath, renovate one bathroom, add fireplace, side porch, A/C, repair/rebuild garage, reno barn, replace roof, windows, replace bathroom, convert heating to oil/hot water, after approval by Building Inspector who stated no site plan or Board of Health required, 4-0. Trustee Shybunko was not signed into the meeting.

Environmental

• On a motion by Mayor Feller, seconded by Trustee Pirro, the Board approved Aronica Plant Health Care, for Galler, 1 Laurel Lane, for the removal of 4 declining or dead trees, after comments from Trustee Gulbransen, Chair of Environmental Committee, who has requested the submittal of a plan, 5-0. Treasurer

New Business

• Village Resolution for adopting the 2020 SC All-Hazards Multi-Jurisdictional Mitigation Plan update, a new mandate required for municipalities in the event of a public health crisis, and to remain qualified for FEMA funding. Attorney Butler clarified the mandate and the Board's role, which is not an active management position.

RESOLUTION NO. 2-2021

A RESOLUTION AUTHORIZING THE ADOPTION OF THE 2020 SUFFOLK COUNTY MULTI-JURISDICTIONAL MULTI-HAZARD MITIGATION PLAN UPDATE

WHEREAS, all jurisdictions within Suffolk County have exposure to natural hazards that increase the risk to life, property, environment, and the County and local economy; and

WHEREAS; pro-active mitigation of known hazards before a disaster event can reduce or eliminate long-term risk to life and property; and

WHEREAS, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for preand post-disaster hazard mitigation programs; and

WHEREAS; a coalition of Suffolk County municipalities with like planning objectives has been formed to pool resources and create consistent mitigation strategies within Suffolk County; and

WHEREAS, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy; and

WHEREAS, the County, in consultation with Tetra Tech, Inc., has prepared and distributed a Suffolk County Multi-Jurisdictional Multi-Hazard Mitigation Plan 2020 Update.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Incorporated Village of Old Field:

- 1) Adopts in its entirety the Suffolk County Multi-Jurisdictional Multi-Hazard Mitigation Plan 2020 Update (the "Plan") as the Village's Natural Hazard Mitigation Plan, and resolves to execute the actions identified in the Plan that pertain to this municipality.
- 2) Will use the adopted and approved portions of the Plan to guide pre- and post-disaster mitigation of the hazards identified.
- 3) Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its jurisdictional authority.
- 4) Will continue its support of the Mitigation Planning Committee as described within the Plan.
- 5) Will help to promote and support the mitigation successes of all participants in the Plan.
- 6) Will incorporate mitigation planning as an integral component of government and partner operations.
- 7) Will provide an update of the Plan in conjunction with the County no less than every five years.
