Pledge to the Flag

The Mayor led the pledge to the flag and opened the meeting at 7:00 PM.

Building

- Building Inspector Joe Arico discussed the delinquent permit renewal list and open permit list; Building Dept. report for Sept., 2022, on file in the Building Dept.
- On a motion by Mayor Pirro, seconded by Trustee Schaefer, the Board approved Hughes, Michael, 10 Blueberry Ridge Rd., SBL 18-3-6, permit #2021-0043, 1st and 2nd floor additions, porch, site plan revision recommended for approval by Village Engineer on Oct. 3, 5-0. (*The site plan approval will cover the entire project; the building permit is for Phase I only. Phase II will include a pool and cabana, and require Board approval for a third accessory building*).
- Pending: Huang, Li, 15 Woodhull Cove Ln., permit #2022-0014, demo and build new family dwelling, site plan revision required as of 05 31 22, and 07 25 2022, by Village Engineer, revised plan submitted 08 25 22

The Mayor asked the Village Clerk on the use policy of the Lighthouse park, due to a large wedding party on the premises on Sat., Oct. 15, observed by the Building Inspector. The park is open to the public, as part of the conditions of ownership when it was deeded to the Village, and is within the Village Code. All persons who notify the Clerk regarding use of the park are informed of any limits, and Code is informed of the date and time. Attorney Guardino said some conditions or limits can be set by the Board. The Clerk requested further clarification, will speak with the Village Attorney.

Environmental Committee-Pending

EC Chair Bruce Feller discussed the tree removal permit for Hughes, 10 Blueberry Ridge Road. The committee recommended approval, citing these are small growth trees and poor material, and considered it a clean-up of the existing over-growth.

- On a motion by Mayor Pirro, seconded by Trustee Schaefer, the Board approved Hughes, Michael, 10 Blueberry Ridge Rd., to remove 67 trees and under growth for future construction project, as recommended by the EC, site plan recommended for approval by the Village Engineer, 5-0.
- On a motion by Mayor Pirro, seconded by Trustee Schaefer, the Board approved Takahashi, Mariko, 52 Crane Neck Rd, to remove 12 trees, 4 shrubs, remove under growth, at the request of the Crane Neck HOA, to improve road visibility on Crane Neck, as recommended by the EC, 5-0.

- Resolution in support of Creation of the Flax Pond Sanctuary, AS AMENDED

WHEREAS, the New York State Assembly and New York State Senate have passed companion bills (A.10187/S.9140) establishing the Flax Pond Tidal Wetlands Sanctuary, which would designate 146.162 acres of tidal wetlands and adjoining lands located in the Village of Old Field for ecological preservation and study, and public recreation, and which would prohibit incompatible activities; and

WHEREAS, the Village of Old Field Board of Trustees finds that the Flax Pond Tidal Wetlands area is an invaluable ecological, aesthetic and recreational resource, and as such, should be protected from development and other misuse so that it may be enjoyed by future generations;

NOW THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Old Field hereby expresses support for A.10187 and S.9140, and authorizes and directs the Mayor to issue a letter to Governor Kathy Hochul urging her to sign the bills into law.
