Lucie Blohm and the HHS Board passed along the letter dated March 16, 2023 from Mayor Thomas Pirro to me regarding the Old Field Lighthouse Keeper's Clock in our collection. Thank you for your patience as we considered the request.

We are thrilled to hear that the lighthouse is being renovated and on its way to becoming a museum. While the clock has been an important part of our collection for over 100 years, we love the idea of it being displayed in its original home.

After discussing it with the Board, we would feel most comfortable putting the clock on permanent loan to the future Lighthouse Museum. Though unlikely, if the Lighthouse Museum were to close, we would want the clock to be returned to the Huntington Historical Society.
