### **Building**

- The Board reviewed Inspector Joe Arico's reports for September and discussed the following items:
- On a motion by Trustee Gulbransen, seconded by Trustee Morrison, the Board approved Permit #2023-0025, Takahashi, Mariko, 52 Crane Neck Road, Tree clearing (12 trees) site plan silk bales must be put in; Renovation to existing one story dwelling as follows: Playroom addition (870sf), basement and garage addition (1,089 sf), stair/hall addition (178sf), porch addition (264 sf), and removal of existing terrace, 5-0
- Mayor Pirro called the next item on the agenda, which was the continuation of the public hearing on an application by Michael Cherouvis #2023-0021, SBL 15-2-21.13, new build for site plan approval for a new single-family residence on the vacant lot at 2 E Gate Lane.

The Trustees, the applicant, and the applicant's architect exchanged comments and questions regarding the application. The Trustees expressed concern over the applicant's plan to install curb cuts on Mt Grey Road and to remove trees within the Village's right-of-way. The applicant refused to modify his plan to place curb cuts on E Gate Lane.

Trustee Schaefer made a motion to approve the site plan on the condition that the applicant be permitted only one curb cut on Mt Grey Road. Mayor Pirro seconded. Mayor Pirro and Trustee Schaefer voted aye, and Trustees Gulbransen, Morrison and Van Der Bogart voted nay. The motion failed.

Mayor Pirro called for the matter to be held over to the Board of Trustees November 2023 meeting. The matter was therefore adjourned to November 6, 2023.
