### Public Hearing(s) re: Code Changes:

- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Van Der Bogart to re-open the Public Hearing concerning Village Code amendments. Motion passed 5-0
- Code changes incorporated input from residents during prior meetings. Changes were presented by Mayor Gulbransen and Trustee Schaefer. Public questions were responded to by the Board.
- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Van Der Bogart to close the public hearing for local law changes to code, Motion passed 5-0
- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Morrison to accept the unlisted action and negative declaration for local laws 07a-2025 and 07b-2025. Motion passed 5-0
- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Morrison to adopt Local Law # 07a-2025 Chapter 108 Trees and clearing substantial alteration/clearing of diverse natural habitat. Motion passed 5-0
- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Morrison to adopt Local Law 07b-2025 Chapter 121 of the Village Code (Zoning) to address substantial alteration/substantial clearing of diverse natural habitat and preservation of natural habitat area. Motion passed 5-0

- Motion was made by Trustee Schaefer and 2<sup>nd</sup> by Trustee Van Der Bogart to accept the SEQRA negative declaration and the decision letter for 96 Old field Road. Motion passed 5-0
- Verizon franchise agreement Village Attorney has been in touch with Verizon who sent a draft agreement but it had the wrong Village referenced, Rachel to follow up with Verizon.

### **Public Comment:**

- Ron Devito inquired as to what the Village is doing with the piles of wood chips. Trustee Morrison advised they will be cleaned up as part of the greater maintenance happening in the Village.
- Rich Hamburg was concerned about the use of large boulders by some residents stating that he believes this to be a danger. Discussion around the liability for any incidents

involving large boulders placed by residents in the right of way. The Mayor advised the Board will address the right of way obstructions in the next set of code changes.

- Lisa Pius advised that a worker at her property noted he has had two shark sitings from her property
- Paul Stegmann thanked Code Enforcement for helping to find a resident's lost dog.
- Jim D'Amico thanked Code Enforcement officer Murphy for his help and guidance with a check fraud issue.
- Christine Smith commented that she called the constable but did not get a call back to her message.
- Dr. Paul inquired if we could pull out the privet around the lighthouse. Trustee Morrison will consider removing invasives as part of the Meadow Plan.
