Deer Fence

- 5 Johns Hollow Rd deer Fence application Recommendation from DFC:
 - The Deer Fence Committee met with Kumar Guddati on Friday October 1 at 4pm. They reviewed the site plan and materials and walked the lines where the fence is to be erected. Small area of fence borders Holly Lane (with a 5 foot setback) and will be well concealed by existing shrubbery. Recommend that this permit be approved.
 - Motion made by Trustee Morrison and 2nd by Trustee Smith to approve the deer fence only portion of the resident's permit. Passed 5-0

- Constant Contact for Absentee ballot applications was sent and copies are available for residents.

Old Business

- Motion to approve Eagle Scout, Emma Larsen's, bench and small bed work project with small adjustment made by Morgan was made by Trustee Morrison and 2nd by Trustee Vander Bogart. The plantings to cost \$250. If the benches are not donated, the Eagle Scout will contact the Mayor. Motion Passed 5-0
- Pomeroy Foundation free signage documentation has been submitted.
- Motion made to select Clovis as the vendor for the tree and bush cleanup of the north eastern side of the lighthouse property made by Trustee Vanderbogart and 2nd by Trustee Smith. Passed 5-0. Morgan will be the lead on the project and ensure the tree trimming limits are not exceeded.
- Serv Pro provided estimate to remediate the lead paint on the interior of the lighthouse windows. The quote was at \$7,000 + to do the windows and clean up the basement floor from the debris that washed in. Need to get a quote to repaint after the clean-up.
- Building (Joe) to provide a detailed procedure document outlining what is handled by Uniform code and un-uniformed code. Trustee Schaefer will make changes to the violation, work stoppage and other forms used by uniformed code using the procedures and explanation document from Joe as a guide.
- Code revisions to section 108 update from Trustee Morrison and Schaefer after review of wording changes from Village Attorney and Uplighting discussion to decide on criteria for Village Dark Sky policy
- Prosecutor Kaufman provided a letter to the Mayor which describes numerous aspects of his efforts to address potential code violations. Update on the recommendations on changes to our documentation of potential violations, new timelines for exchanging information, and code which could be improved. Trustee Schaefer and Prosecutor Kaufman working on tightening up code.
- Modern Ruins references came back with positive recommendations from past MR customers.
